

# Compliance with the EU Sustainable Financial Disclosure Regulation (EU SFDR)

Impact Expansion Fund I ("the Fund") regards itself as an Article 9 fund according to the definition included in the EU SFDR. All the requirements of Article 9 fund are considered and are at the core of our investment decisions.

#### 1- SUMMARY

Impact Expansion team invests the Fund by combining the vision of impact investment with the financial rigour and business-building capability of private equity to generate superior returns while delivering meaningful social and environmental impact, carefully targeted at areas of major needs in Western Europe. These areas of needs identified in our Theory of Change¹ based on existing researches and data, comprise (i) structural unemployment, (ii) bad health and (iii) climate crisis and environmental degradation.

The overall objective of the Fund is to enhance and maximise the positive social and environmental impact (referred as "impact" in the rest of this document) of its portfolio companies on all stakeholders including employees, clients/patients and impacted communities, as relevant and appropriate, while at the same time minimising and controlling adverse sustainability and ESG-related effects/risks ("Do not harm" principle). To achieve this objective, the Fund will accompany the companies it invests in getting to the next step of their development by providing growth capital and strategic and operational support for their organic and M&A (buy-and-build).

In addition to the Impact focus, Impact Expansion endeavors to carry out its investment activity with appropriate consideration for sustainability risks including climate change-related risks (transitional and physical) and environmental, social, and governance (ESG) aspects derived from the companies financed by the Fund. Impact Expansion team views sustainability risks and ESG management essentially as a risk-management tool which it will use to analyse and monitor the risks of the Fund's portfolio. The Fund's objective is the generation and enhancement of positive social and environmental impact and attractive financial returns; this objective is the driving force of the Fund's investment strategy and its achievement the focus of Impact Expansion team.

Impact Expansion team requires businesses the Fund invests in, at a minimum, to comply with the legal and regulatory requirements of the jurisdictions where they operate and respect the UN Global Compact Principles, and ensures that its portfolio companies tend towards the appropriate level of corporate governance.

The impact assessment, measurement and management process is organised throughout the investment process, from sourcing to exit. In parallel, we also integrate a sustainability risk assessment that is considered in the investment decision process and that we aim to monitor during the holding period until the exit.

The Fund does not use a market reference benchmark for the impact it will generate. However, before investing in a company, it will define with the management of the company, between one and five KPIs for which it will set targets that the Fund's underlying companies will aim to achieve during the Fund's ownership and that will be tracked on a quarterly basis. The impact KPIs are aligned with the social and environmental objectives of the Fund and the achievement of the impact's targets are reflected in portfolio companies' management annual remuneration as well as ultimately Impact Expansion's team carried interest (50% of the Fund's carried interest is linked to the achievement of the underlying companies impact targets, aggregated at the Fund's level). Impact KPIs and the targets set for each KPI are reviewed by an independent

Impact Committee at entry and the impact performance achieved validated by the same Committee and signed off by an external auditor when the Fund exits each investment.

#### 2- "NO SIGNIFICANT HARM TO THE SUSTAINABLE INVESTMENT OBJECTIVE"

#### Sustainability Risk and ESG matters overview

Despite generating positive impact, some of the companies Impact Expansion invests in can still generate negative outcomes (sustainability risks/ESG negative externalities), which we commit to help our portfolio companies estimate and mitigate ("Do Not Harm Principle"). As part of our due diligence process implemented for each investment opportunity, we include a full analysis of the sustainability risks and a mapping of key ESG indicators.

#### Sustainability risks

Sustainability risks are an important factor to take into account during the investment process, as well as during the investment period. At Impact Expansion, we developed a simplified version of the TCFD<sup>2</sup> framework, which is more applicable to the type of companies the Fund invests in (unlisted companies generating a few million euros of revenues per year, with generally simple business models).

As part of our due diligence when we analyse an investment opportunity, Impact Expansion deal team runs a climate risks assessment of the target company, using the table displayed on the next page. The information collected is analysed and the results are included in the Final Investment Memorandum (FIR) which is the document summarising the outcome of the deal team due diligence, presented to the Investment Committee and used by its members to take the final investment decision.

Once an investment is closed, the key risks (risks with a score from 4 to 9<sup>3</sup>) identified during due diligence are discussed at the board level of our portfolio companies on an annual basis, to ensure they are efficiently tracked and tackled. If new risks are identified during the holding period, the sustainability risk table is updated. Special attention is paid to businesses active in the energy, agriculture, transport and construction sectors, as these sectors are more at risk when it comes to climate change.

As a general rule, the Fund does not invest in companies which present sustainability risks above 6 (red risks) that cannot be mitigated. However, in specific and unlikely cases where the Investment Committee decides to invest in a company presenting a red risk which cannot be mitigated, because it concludes that the social or environmental impact of the investments more than compensate the sustainability risks, it needs to explain the rationale of its investment decision to the Impact Committee<sup>4</sup>.

The results of the above Sustainability table are considered to adapt the company's valuation during the holding period.

#### **ESG Matters**

In addition to the sustainability risk analysis, we also collect and analyse key ESG indicators, which we commit to map and track annually at portfolio company level in order to monitor ESG risks. When a material and relevant ESG risk is identified, we will engage with the management of our portfolio companies to work on an action plan aimed at mitigating it. These key ESG indicators are based on the EU SFRD Principal Adverse indicators (PAIs), and are part of the reporting requirements. The table below displays the PAIs indicators we commit to map and track<sup>5</sup>:

Principal Adverse Indicators (PAIs) 1 to 14 are the official indicators which are requested to be tracked by Article 9 of the EU Sustainable Finance Disclosure Regulation ("EU SFDR"). There are four additional compulsory PAIs, but they only apply to Sovereign and Real Estate investing, which are not part of the Fund's investment strategy; we have therefore not included them in our tracking table. Indicators 15 and 16 were selected within the rest of the EU SFDR PAIs based on their relevance to Impact Expansion's portfolio companies.

When reporting on the PAIs on an annual basis, we are using the Principal Adverse Indicators Disclosure Statement, displayed in Appendix 1 of the Regulatory Technical Standard – April 2022.<sup>6</sup>

Given the type of companies we are targeting for the Fund, i.e. companies that generate positive environmental and social positive impact, we anticipate that the companies we invest in will not display meaningful ESG risks.

Overall, the priority on the environmental side are put on indicators 1, 2, 3, 4 and 7. Indeed,

we expect to invest in very few companies with industrial production process and therefore, PAIs 6 and 9 generally do not apply. Also, given our focus on investing in companies that bring solutions to the climate crisis and environmental degradation, we avoid high-emission sectors and therefore indicator 8 will rarely apply.

On the social side, indicators 10 and 12 are exclusive criteria to invest; if they are not nil, the Fund does not invest. Our priority is therefore on improving indicators 11, 13, 14, 15 and 16, for which we support our portfolio companies.

The ESG risks measured by the PAIs are considered at the time of the investment decision as well as during the monitoring phase as explained in the following sections. The evaluation and mitigation processes of ESG risks will be improved and fine-tuned during the life of the fund.

#### Alignment of the Fund Manager with International Guidelines

Impact Expansion team requires businesses the Fund invests in, at a minimum, to comply with the legal and regulatory requirements of the jurisdictions where they operate and respect the UN Global Compact Principles<sup>7</sup>, and ensures that its portfolio companies tend towards the appropriate level of corporate governance, including a board of directors comprising Impact Expansion's professionals and independent members (when possible), a management team with defined roles, KPIs and transparent and audited financial statements.

The overall objective of the Fund is to help its portfolio companies enhance and maximise their positive impact on the society and the environment while minimising their adverse effects on all stakeholders, including employees, clients/patients and impacted communities, as relevant and appropriate.

#### 3- SUSTAINABLE INVESTMENT OBJECTIVE OF THE FINANCIAL PRODUCT

#### Overview

The Impact Expansion team, which manages the Fund, is convinced of the essential role that the private sector, and particularly private businesses, can play in creating a more inclusive and sustainable society.

Based on this conviction, Impact Expansion team invests the Fund by combining the vision of impact investment with the financial rigour and business-building capability of private equity to generate superior returns while delivering meaningful social and environmental impact, carefully targeted at areas of major needs in Western Europe. These areas of needs identified in our Theory of Change<sup>8</sup> based on existing research and data, comprise (i) structural unemployment, (ii) bad health and (iii) climate crisis and environmental degradation.

The overall objective of the Fund is to enhance and maximise the positive social and environmental impact (referred as "impact" in the rest of this document) of its portfolio companies on all stakeholders including employees, clients/patients and impacted

communities, as relevant and appropriate, while at the same time minimising and controlling adverse sustainability and ESG-related effects/risks ("Do not harm" principle). To achieve this objective, the Fund will accompany the companies it invests in getting to the next step of their development by providing growth capital and strategic and operational support for their organic and M&A (buy-and-build).

#### Environmental and Social characteristics of the Fund

The Fund seeks to identify and invest in businesses that provide best-in-class solutions to these large-scale needs in the education/formation/skilling, health services and environmental-related sectors and have the potential to substantially grow into new geographies or markets, through organic growth and M&A, thereby increasing the scale and reach of the benefits generated by each company to its stakeholders (impact scaling strategy).

Based on its Theory of Change, the Fund identified the following SDGs it aims to address:













- SDG 3 «ensuring healthy lives and promoting well-being for all at all ages»
- **SDG 4** «ensuring inclusive and equitable quality education and promoting lifelong learning opportunities for all»
- **SDG 7** «ensuring access to affordable, reliable, sustainable and modern energy for all»
- SDG 8 «decent work and economic growth»
- **SDG 10** «reduce inequality within and among countries»
- **SDG 13** «taking urgent action to combat climate change»

In addition to the Impact focus, Impact Expansion endeavors to carry out its investment activity with appropriate consideration for sustainability risks including climate changerelated risks (transitional and physical) and environmental, social, and governance (ESG) aspects derived from the companies financed by the Fund. Impact Expansion team views sustainability risks and ESG management essentially as a risk-management tool which it will use to analyse and monitor the risks of the Fund's portfolio. The Fund's objective is the generation and enhancement of positive social and environmental impact and attractive financial returns; this objective is the driving force of the Fund's investment strategy and its achievement the focus of Impact Expansion team.

#### Impact Expansion Impact and Sustainability Commitments

Impact Expansion is strongly committed to:

- guarantee that the pursue of impact (intentional social and environmental objectives) at the core of our investment strategy, is reflected in its processes, from origination to exit, is measured against pre-defined targets, evaluated and reported upon to the Fund's investors and that Impact Expansion team is aligned financially with the impact performance of the Fund;
- pursue ethical behaviour in general, including respect for all its related stakeholders9, transparent and fair decision-making processes; and the adoption of a long-term view of investment development;
- integrate sustainability risks and ESG matters (risk management) into investment analysis and life cycle: sourcing and initial screening, due diligence, investment

decision-making and investment agreement, management over the entire holding period and exit process;

- require businesses the Fund invests in, at a minimum, to comply with the legal and regulatory requirements in the jurisdictions where they operate and respect the UN Global Compact Principles<sup>10</sup>;
- ensure that the Fund's portfolio companies tend towards the appropriate level of corporate governance, including a board of directors comprising Impact Expansion's professionals and independent members (when possible), a management team with defined roles, KPIs and transparent financial statements;
- support its portfolio companies in enhancing and maximising their positive impact on society and minimising their adverse effects on the environment and all stakeholders, as relevant and appropriate;
- encourage its portfolio companies to make efficient use of natural resources and to protect the environment wherever possible and support the reduction of greenhouse gas emissions;
- provide its investors with transparent and relevant information on the impact the Fund's portfolio companies are generating and inform them on sustainability and ESG risks related to its investment activity, while observing the appropriate commercial confidentiality requirements.

#### 4- INVESTMENT STRATEGY

#### **Investment Strategy and Approach**

Impact Expansion is an impact-focused fund manager, and impact investing is at the core of our investment strategy. The Fund targets and invests in impactful companies where impact is an integral part of their business model and therefore aligned with the company's financial performance. The targeted companies offer solutions to the three areas of needs identified in our Theory of Change: (i) structural unemployment, (ii) bad health and (iii) climate crisis and environmental degradation. As such, all the companies we have and will invest in promote social and environmental characteristics.

The charts below summarise our investment strategy:



and the graph below summarises our Impact Investing approach:



The **intentionality** is defined in our investment strategy. Impact Expansion Fund I, "the Fund", focuses on access to affordable, effective healthcare; improvement of life opportunities through education and skill development; and protection of the environment (transition to a low carbon economy including waste management, renewable energy, eco-friendly agriculture and food production solutions, circular economy), where it has observed that the need to tackle recognised problems, combined with government budget limitations and insufficient delivery in Western Europe, has created a substantial base of forward-looking companies developing new solutions to endemic social and environmental problems. As mentioned previously, the Fund aims to address at least six of the 17 SDGs (#3, #4, #7, #8, #10 and #13), but will also contribute to others including SDGs #12 ("Responsible consumption and production") and #17 ("Partnership for the goals"). Each of our investments need or will need to contribute to at least one of the six SDGs of focus.

The **impact measurement, assessment and management** process is organised throughout the investment process, from sourcing to exit (please refer to the next section for further details).

In terms of financial returns, the Fund targets gross IRR of 20% and gross investment multiple of 2.5x, which is in line with what the partners have achieved with their European Impact or Impact-leaning investments over the last 10 years. This objectif is related to SDG 8, which aims to generate economic growth.

#### Sustainability Risk and ESG matters

Despite generating positive impact, some of the companies the Fund invests in can still generate negative outcomes (sustainability risks/ESG negative externalities), which Impact Expansion team commits to help its portfolio companies estimate and mitigate ("Do Not Harm Principle"). As part of its due diligence process implemented for each investment opportunity,




Impact Expansion includes a full analysis of the sustainability risks and a mapping of key ESG indicators as described in the previous section.

#### **Ensuring a sound governance**

For each new company that Impact Expansion team analyses for the Fund with a view to invest, it performs a full due diligence that includes, in addition to the market, financial and commercial due diligence, a review of the governance practices of the company. If deficiencies are identified during this process, the deal team will: (i) evaluate if these deficiencies can be easily remediate; (ii) if that is the case and that the rest of the due diligence is satisfactory, it will work with the portfolio company to reach the appropriate level of corporate governance, including a board of directors comprising Impact Expansion's professionals and independent members (when possible), a management team with defined roles, KPIs and transparent and audited financial statements; and (iii) if it believes the deficiencies are not remediable, it will decline the investment opportunity.

#### 5- PROPORTION OF INVESTMENTS

## The asset allocation and the minimum share of sustainable investments of the Fund



The Fund invests directly into companies. The Fund's focus on sustainable investments combined with the management of potential negative externalities together with the due diligence that Impact Expansion performs to ensure good governance practices of the companies it invests in, leads to the conclusion that the Fund is expected to be at least 90% invested in sustainable investments based on the EU SFDR's definition. The remaining 10% will be cash or cash equivalents held for liquidity purposes as well as hedging instruments, which will not qualify as sustainable investments (#2 Not sustainable).

#### 6- MONITORING OF SUSTAINABLE INVESTMENT OBJECTIVE

The impact assessment, measurement and management process is organised throughout the investment process, from sourcing to exit. In parallel, we also integrate a sustainability risk assessment (as described previously) that is considered in the investment decision process and that we aim to monitor during the holding period until the exit.



The Fund does not use a market reference benchmark for the impact it will generate. However, before investing in a company, it will define with the management of the company, between one and five KPIs for which it will set targets that the Fund's underlying companies will aim to achieve during the Fund's ownership and that will be tracked on a quarterly basis. The impact KPIs are aligned with the social and environmental objectives of the Fund and the achievement of the impact's targets are reflected in portfolio companies' management annual remuneration as well as ultimately Impact Expansion's team carried interest (50% of the Fund's carried interest is linked to the achievement of the underlying companies impact targets, aggregated at the Fund's level). Impact KPIs and the targets set for each KPI are reviewed by an independent Impact Committee at entry and the impact performance achieved validated by the same Committee when the Fund exits each investment, before being signed off by an external auditor.

#### **Investment Monitoring**

For information to be fully standardised, each individual Impact and ESG indicators will be disclosed based on Impact Expansion impact methodology that is inspired by the COMPASS/IMP for the impact analysis and measurement and the definitions provided by the EU SFDR for the ESG indicators (PAIs). The Sustainability Table will be updated once a year.

The pre-defined impact targets of each portfolio company are tracked quarterly (unless specified otherwise). The monitoring team reviews the intermediary impact indicators to make sure that (i) each investee is on track to deliver the expected impact, and (ii) there is no mission drift detected. In case of a discrepancy between each intermediary impact objective and the realised indicator value, the monitoring team investigates further to explain the specific reasons of the difference and works with the portfolio company to make sure it can get back on track in an acceptable timeframe. Impact achievements will be considered yearly for management compensation package, using, but not limited to, the impact KPIs defined in the pre-investment phase and included in the shareholder agreement of each of our portfolio companies.

To ensure ESG indicators are collected and reported in a standardised way, Impact Expansion aligns its data with the EU SFDR<sup>11</sup> Principal Adverse Indicators (PAIs)<sup>12</sup> and definitions. In reporting on the PAIs, we will be using the Principal Adverse Impact Disclosure Statement, displayed in Appendix 1 of the Regulatory Technical Standard – April 2022. On a semi-annual basis and when applicable, Impact Expansion reviews with the portfolio company management, if applicable, the implementation of the action plan aimed at mitigating/avoiding any material ESG risk, evaluated using the PAIs listed above, and raises and requests the portfolio company to address any identified unintended ESG related negative impacts.

The sustainability risks identified at the time of the due diligence using the Sustainability Risk Table (green, orange and red risks), will be tracked during the holding period and considered by the Fund to (i) adapt the valuation of the company for its quarterly and annual reporting; (ii) to evaluate whether the sustainability risks have evolved; and (iii) to report any new potential and meaningful sustainability risks to our investors.

For companies aiming to fight climate change, impacts will be tracked following the impact methodology (definition of one to five KPIs and targets tracked throughout the life of the investment), with a specific focus on greenhouse emissions avoided. As explained in the Fund's Investment Strategy, the companies the Fund invests in, in the environmental space, are expected to bring solutions to fight climate change, and consequently to achieve the Paris Agreement objective of reaching 1.5 degrees Celsius above pre-industrial level and achieving a carbon-neutral EU by 2050.

#### Risk of mission drift

If a mission drift occurs, an Impact Committee is called to discuss the case. Three situations could emerge:

- Original positive impact reduced or eliminated, along with the appearance of new positive impacts/externalities;
- Original positive impact reduced or eliminated, along with the appearance of new negative impacts/externalities;
- Original positive impact reduced or eliminated and no new impact (negative or positive) created.

If the situation is deemed overall positive(for example the positive impact generated is in line with our Theory of Change and more than compensates for the negative impact caused by the mission drift), the Impact Expansion team and the Impact Committee will discuss the new impact KPIs and objectives to track during the remaining life of the investment, and steps will be taken to reduce as much as possible the negative impact/externalities.

If the situation is deemed overall negative (for example the negative impact generated by the missions drift is more than compensated by the positive impact), the Impact Expansion team will present to the Impact Committee a strategy to tackle the issue. Examples of such next steps could be:

- a change in business strategy to stop negative impact/externalities;
- a change in business leadership if there is an issue with its intentionality;
- planned exit of the investment in case the negative impact/externalities are judged unsustainable by Impact Expansion Investment Committee and cannot get mitigated.

The situation would be discussed at each future Impact Committee until it is resolved.

#### Exit stage

At the exit stage, the monitoring team collects all the impact data from each portfolio company and compares them with the initial targets, to assess whether the Fund's impact objectives have been achieved or not. In case of discrepancy between the objectives and the realised impact, the team investigates the reasons for not achieving the objectives to (i) explain them to the Impact Committee and the Limited Partners Advisory Committee, and to (ii) prevent the repetition for similar investments/errors in the future.

At the time of each investment exit, the Impact Committee will validate the level of achievement of the impact performance, measured by the difference between the target impact KPIs and the level of impact KPIs ultimately achieved during the holding period. If it has a doubt or requires further clarification on the impact performance data communicated by the



monitoring team, the Impact Committee can involve an Impact Expert from the Pool. In all cases, the impact performance will be signed off by an external auditor<sup>13</sup>.

An evaluation of the sustainability risks will be implemented prior to the exit and taken into account to set the targeted exit price for the Fund's investment. When applicable, a report will be produced to reflect the progress made on the ESG-related action plan to manage and mitigate material ESG risks identified during the holding period, which will be shared with the potential buyers.

#### Reporting

Across the investment cycle, Impact Expansion will report its impact performance and ESG PAIs to its investors and its staff.

- Impact KPIs will be reported and communicated to the fund's investors on a perinvestee-company basis (as their activities across different sectors and geographies are not directly comparable) and compared with the annual and final targets;
- The team will follow its Impact Methodology<sup>14</sup> based on Impact Expansion impact methodology that is inspired by the COMPASS/IMP framework for the evaluation of the Fund's Impact Performance;
- The ESG PAIs will be collected at the investee-company basis and at the Fund level (when possible) and on an annual basis in compliance with the EU SFDR, reported when requested by the investors.

# Impact Expansion's team alignment with the Fund's impact performance

The entire team is aligned with the Fund's Impact objectives. Members of the team came together not only because of their shared vision of the future opportunity within the growth impact investing space, but also because of their shared culture and values, which are based on a deep respect for other people and the wider world and their commitment to creating a better planet and society.

In addition to the individual commitment of each of the team members to impact, the team is ultimately financially aligned with the social and environmental impact performance of the Fund. Indeed, half of the team's carried interest (10 basis points of the 20% carried interest allocated to the Impact Expansion team) is linked to the achievement the Impact Performance at the Fund's level. If the impact performance is not achieved at the Fund's level, the "impact carried interest" will be allocated to NGOs that focus on the impact themes the Fund promotes.

There is no direct financial alignment between the Sustainability risks / ESG-related indicators and Impact Expansion's carried interest, because, as mentioned earlier, the team views the sustainability risk / ESG management essentially as a risk-management tool, not at the core of its value creation strategy aimed at creating positive impact. This is the main reason why portfolio companies and Impact Expansion team will solely be financially aligned with the impact performance of the Fund.

#### 7- METHODOLOGY

#### **Impact Methodology**

The methodology used to manage and measure each portfolio company impact is based on Impact Expansion impact methodology that is inspired by the COMPASS methodology<sup>15</sup> – a public standardised impact measurement methodology developed by the Global Impact Investment Network (GIIN), based on the IMP Framework, and aimed at enabling investors to compare the impact performance across their individual/fund investments.

The impact measurement methodology will be implemented as explained below.

#### 1.1. Define the impact context

Impact Expansion seeks to incorporate impact into decision-making across its investment process by leveraging impact performance information to answer a series of critical, strategic questions. These questions help define which impact metrics are relevant, as well as what are the relevant variables for disaggregating and clustering analyses. These questions follow the various stages of the investment process in which investment decisions are made and strategy is set. The table below reflects high-level questions Impact Expansion will ask itself; each key question can be further disaggregated into a series of sub-questions.

Investment process stage	Key questions
Deal screening	What types of opportunities are most likely to enable to achieve the fund impact goals within its risk, return, and liquidity parameters?
Due diligence	Which investments have the greatest potential to create the impact targeted by the Fund? What amount of impact is likely?
Investment management	Where is the portfolio under- or out-performing on impact, and how to engage with portfolio companies accordingly?
Exit	When and how should the investments be exited, given the impact goals and fund mandate? How do we ensure the impact focus will be maintained once the Fund exits its investments?
Reporting	What are the issues the Fund/portfolio company are seeking to address? What impact has the fund/portfolio company achieved? How does this impact compare to its goals and peers?

#### 1.2. Complementary evaluation

Beside the consolidated impact monitoring and reporting, Impact Expansion is running a complementary qualitative and/or quantitative evaluation (having no impact on the carried interest calculation). The objective of this complementary analysis will be to understand better:

- the scale of impact results, the assessment generates insight into outcomes achieved by an investment each year. This outcome figure represents the first of three analytic figures to gauge the portfolio company performance.
- the change that has occurred. This figure allows to gauge progress relative to the pace of change needed to achieve a given SDG or meet science-based targets, offering insight into performance.
- the efficiency with which an investment has created impact. To assess this variable it
  is possible to consider the cumulative outcomes of a given investment since inception
  and divide it by the size of the investment, which can be a useful metric to compare
  investments between them.

#### 8- DATA SOURCES AND PROCESSING

#### Collect impact data

To answer the questions defined in the previous step and to generate impact performance insights, Impact Expansion collects a set of information as standard as possible. The data collection will consider possible variations in data quality of each target/portfolio company — most notably the reliability and precision of data, as well as aspirations for the types of insights that impact data may be able to elevate.

Eeach individual metric will be disclosed using consistent categories, calculations, units, time periods, and assumptions. To ensure impact data are collected and reported in a standardised way, Impact Expansion intends to align its impact metrics to the IRIS+ system when ever possible. Additionally, the Impact Management Project's Dimensions of Impact describe five dimensions of impact (Who, What, How Much, Risk, and Contribution) in an effort to provide a common and comparable language for defining and communicating impact.

Additionally, the COMPASS methodology leverages five categories of information to generate insight into impact performance. This includes three categories reflecting information tracked and gathered by the investor: investment context, investee context, and impact results; and two categories that further support and contextualise the information collected: the evidence base and performance thresholds.

#### PAIs data collection

In addition to the Impact data collection, Impact Expansion will also be collecting the Principal Adverse Impact Indicators from each portfolio company on a yearly basis. The list of PAIs and the definitions/measures included in the EU SFDR are provided to the portfolio company and the requirement to report on an annual basis included in the shareholder agreement. For the data where it believes its companies will have most difficulty with (for e.g. scope 3 of its carbon emission), Impact Expansion will use estimates and/or support its companies in generating the necessary data.



#### 9- LIMITATIONS TO METHODOLOGY AND DATA

When Impact Expansion defines the impact KPIs for its portfolio companies, it makes sure that these are quantitatif KPIs that are relatively easy to evaluate. The Impact KPIs and their targets are validated by the Impact Committee which is independent from the Fund Manager and that has access to a pool of over 30 impact expects specialised in the three themes of the investment strategy (health, environment and education/formation).

Complementary impact analysis will rely on a more subjective evaluation which will be harder to proof. This represents a limitation to the methodology used, but as mentioned previously, this more subjective analysis will be performed by the Fund Manager to better understand the scale, depth and efficiency of the impact generated, without influencing the impact carried interest of the Fund.

As regards to the collection of the PAIs indicators, there will be situations where the evaluation of specific indicators will need to be estimated (for e.g. scope 3 of the carbon emissions) as most of the companies in which the Fund invests will not have the resources to evaluate them. Estimating this type of indicator is a common practice, even for larger companies, but still represents a limitation of the methodology used.

#### **10- DUE DILIGENCE**

The impact measurement and assessment is organised throughout the investment process, from sourcing to exit. This section focuses on the stage of analysis and due diligence of an investment opportunity.

#### Sourcing and Initial screening

The Fund invests only where impact is core to the company business model and an integral part of the product or service offered. Specifically, the team focuses on selecting companies whose impact is closely correlated to financial performance, in order to achieve the Fund's objective of delivering impact alongside attractive financial returns.

The deal team conducts an impact analysis at the screening stage of potential investment opportunities. The analysis specifically aims to assess the (i) intentionality, (ii) measurability, and (iii) additionality of the impact generated by each potential investment target. Preliminary impact indicators to track are also defined and discussed. In this process, the deal team can consult the Impact Expert Pool (comprised of impact experts in each of the themes the Fund targets) on case-by-case basis, depending on its members' respective field of expertise. The results of this initial analysis are subsequently presented to the Fund Investment Committee for validation, and only target companies that fulfil a minimum threshold for the three evaluation criteria above are analysed further.

Alongside the impact evaluation, Impact Expansion compiles, when appropriate, environmental, social and governance indicators and evaluate if the target company presents critical sustainability risks using the Sustainability Risk Table (displayed previously). These risks will be balanced with the positive impact the target company generates and is expected to generate, and an evaluation will be made on the ways to mitigate them.



#### **Due Diligence**

The team conducts in-depth impact analysis, based on Impact Expansion impact methodology that is inspired by widely accepted tools and frameworks (COMPASS/ Impact Management Project Framework - IRIS+ indicators when available), to assess the full impact generated by each portfolio company, including direct and indirect impacts, both positive and negative, with the view to maximise the overall positive impact of the aggregated portfolio and avoid significant negative externalities. Specifically, the deal team will assess (i) whether the target company offers a solution to the needs indentified in Impact Expansion's theory of change, (ii) alignment between the business and impact objectives of the Fund, as well as (iii) definitions, measurement, and historical impact track record of the target; and (iv) whether the target company generates or could generate significant negative externalities. At the end of this stage, in coordination with the target's management team, the deal team defines a set of (existing and/or new) impact indicators (KPIs) and targets for the purposes of the investment management and impact reporting. One to maximum five main quantitative impact indicators are chosen and tracked, reported to investors and used for the carried interest calculation. Each indicator receives a percentage weight and a yearly objective to be reached by the management. These impact KPIs and targets are reviewed and validated by the Impact Committee following the process described in Impact Expansion's Impact Procedures and Process manual.

Information related to the sustainability risks are collected and analysed as part of the due diligence process (using the methodology described above) to evaluate the transition and physical risks related to the target company. An evaluation of the governance of the company is also implemented and the Fund will only invest in companies with the appropriate level of corporate governance, including a board of directors to include Impact Expansion's professionals, a management team with defined roles, KPIs and transparent and audited financial statements. The sustainability risks and governance due diligence are considered to assess the sustainability of the target company business and determine its entry valuation.

Before signing an investment, the target company's management team is also informed on the list of ESG indicators (PAIs indicators listed in the table page 6) that needs to be provided on an annual basis to the Fund and, is requested to provide an action plan to mitigate/avoid the identified or potential material ESG risks.

#### **Investment Decision**

Once the target impact indicators proposed by the deal team have been validated by the Impact Committee, they are presented in the Final Investment Review report (FIR), which the Fund's Investment Committee receives prior to the final investment decision. This report will also include the sustainability risks due diligence findings. In order to go ahead, the investment opportunity will need to be approved unanimously by Fund's Investment Committee members.


The impact KPIs and targets as well as the ESG indicators to report on will be included in the shareholder agreement signed with the target company.



#### 12- ATTAINMENT OF THE SUSTAINABLE INVESTMENT OBJECTIVES

The Fund hold its final closing on June 28th, 2024. Impact Expansion has produced its first EU SFDR reporting in June 2024 (given that there were no assets in the Fund as of December 31st 2022), where the PAIs indicators were included.

The Fund does not use a reference benchmark. However, before investing in a company, it defines with the management of the company, between one and five impact KPIs for which it sets targets that the company will aim to achieve during the Fund's ownership and that Impact Expansion monitoring team will track on an annual basis. The impact KPIs are aligned with the social and environmental objectives of the Fund and the level of achievement of the targets will impact portfolio companies' management annual remuneration.

The table below reflects the 2023 aggregated impact performance, based on the KPIs and achievement objectives defined pre-investments, of the first three investments of the Fund.

#### **APPENDIX 1**

#### Sustainability Risk Table: Definitions and further explanation

#### 1. Transition Risks

Transitioning to a lower-carbon economy may entail extensive policy, legal, technologic, and market changes to address mitigation and adaptation requirements related to climate change. Depending on the nature, speed, and focus of these changes, transition risks may pose varying levels of financial and reputational risk to organisations.

#### a) Policy and Legal Risks

Policy actions around climate change continue to evolve. Their objectives generally fall into two categories—policy actions that attempt to constrain actions that contribute to the adverse effects of climate change or policy actions that seek to promote adaptation to climate change. Some examples include implementing carbon-pricing mechanisms to reduce GHG emissions, shifting energy use toward lower emission sources, adopting energy-efficiency solutions, encouraging greater water efficiency measures, and promoting more sustainable land-use practices. The risk associated with and financial impact of policy changes depend on the nature and timing of the policy change.

Another important risk is litigation or legal risk. Recent years have seen an increase in climate-related litigation claims being brought before the courts by property owners, municipalities, states, insurers, shareholders, and public interest organisations. Reasons for such litigation include the failure of organisations to mitigate impacts of climate change, failure to adapt to climate change, and the insufficiency of disclosure around material financial risks. As the value of loss and damage arising from climate change grows, litigation risk is also likely to increase.

#### b) **Technology Risk**

Technological improvements or innovations that support the transition to a lower-carbon, energy- efficient economic system can have a significant impact on organisations. For example, the development and use of emerging technologies such as renewable energy, battery storage, energy efficiency, and carbon capture and storage will affect the competitiveness of certain organisations, their production and distribution costs, and ultimately the demand for their products and services from end users. To the extent that new technology displaces old systems and disrupts some parts of the existing economic system, winners and losers will emerge from this "creative destruction" process. The timing of technology development and deployment, however, is a key uncertainty in assessing technology risk.

#### c) Market Risk

While the ways in which markets could be affected by climate change are varied and complex, one of the major ones is through shifts in supply and demand for certain commodities, products, and services as climate-related risks and opportunities are increasingly taken into account.

#### d) Reputation Risk



Climate change has been identified as a potential source of reputational risk tied to changing customer or community perceptions of an organisation's contribution to or detraction from the transition to a lower-carbon economy.

#### 2. Physical Risks

Physical risks resulting from climate change can be event driven (acute) or longer-term shifts (chronic) in climate patterns. Physical risks may have financial implications for organisations, such as direct damage to assets and indirect impacts from supply chain disruption. Organisations' financial performance may also be affected by changes in water availability, sourcing, and quality; food security; and extreme temperature changes affecting organisations' premises, operations, supply chain, transport needs, and employee safety.

#### a) Acute Risk

Acute physical risks refer to those that are event-driven, including increased severity of extreme weather events, such as cyclones, hurricanes, or floods.

#### b) Chronic Risk

Chronic physical risks refer to longer-term shifts in climate patterns (e.g., sustained higher temperatures) that may cause sea level rise or chronic heat waves.
